# The role:

- Advise on country specific energy framework, investment codes and applicable regulatory processes in obtaining the required project specific licenses, permits and permissions;
- Draft, negotiate, provide legal advice, and lead on company incorporation and acquisitions; including shareholder and share purchase agreements, joint ventures and joint developments;
- Proactively assess evolving compliance requirements such as those relating to licensing, marketing, privacy, data security and employment law, providing reports and analysis as applicable;
- Manage the corporate governance function across the Group including drafting and implementing senior management charters including shareholder and director responsibilities;
- Arrange and manage board and shareholder meetings, managing company specific statutory books and annual compliance filings;
- Implement risk assessment framework and conduct assessments to identify and rank current risks, recommend strategies to mitigate identified gaps and/or take corrective actions to implement solutions to improve controls and operations;
- Plan, organize, and manage resources to successfully complete specific objectives while maintaining scope, quality, time and budget restrictions;
- Draft, implement and monitor effective compliance of company policies and procedures including financial crime such as Anti-Bribery and Corruption (ABC) including KYC, FCPA, sanctions and monitoring local permits/licenses, with defined systems and measures appropriate to the level of risk exposed to;
- Lead all disputes and litigation matters within the group including coordination with external counsel retained for litigation and other disputes;
- Define legal strategies with regards to corporate and project-related matters across the business.
